The form of government ethics is the ideal rules stipulated in the Constitution and outlined in the State Basics (Pancasila) and the National Struggle Basics (Declaration). From the summary of expert opinions above, it can be concluded that the role of supervision in increasing accountability is very important in the context of education administration and the public sector in general. Oversight can be an effective tool for increasing transparency, accountability, and quality in educational administration by providing close supervision, enforcing rules, preventing abuse of power, and supporting innovation.

Stansbury and Barry's (2007) research shows that monitoring plays an important role in disclosing important information to affected parties. In his writing, De Renzio (2011) emphasized that supervision is not just controlling and enforcing regulations, but also as a means of increasing the openness and accessibility of public information. A study conducted by McCourt and Eldridge (2003), found that monitoring is essential to support wider deployment of practices within organizations (McCourt & Eldridge, 2003). Strict supervision makes public institutions more willing to share information with the public, increasing transparency. Hope and Fraser's (2003) view emphasizes that effective supervision encourages public accountability and assesses organizational performance. Public institutions can increase transparency and increase interaction with the public by providing information openly and honestly (Hope & Fraser, 2003).

Supervision Strategies in Education

According to Koesrindartoto (2018), a monitoring strategy is a group of plans or procedures that aim to ensure that the performance of organizational activities runs effectively, efficiently and in accordance with standards.
